Apache Software Foundation policy on Using 3rd-party code

- As identified by Apache Software Foundation 3rd Party License Policy (<https://www.apache.org/legal/resolved.html> for full list)
 - Category A: “Apache like”, may be used as part of ASF product
 - Apache 2.0, Apache 1.1 (PHP 3.01, MX4J)
 - BSD (BSD 2-clause, BSD 3-clause, DOM4J, PostgreSQL, Eclipse Distribution License 1.0),
 - MIT/X11 (ISC, Standard ML of New jersey, Cup Parser Generator)
 - Python Software Foundation License 2.0
 - Google "Additional IP Rights Grant (Patents)" file
 - ...
 - Category B: may be used under certain conditions (labeling, binary-only)
 - Eclipse Public License: EPL 1.0, EPL 2.0
 - Open Software License 3.0
 - Mozilla Public Licenses: MPL 1.0, MPL 1.1, and MPL 2.0
 - ...
 - Category X: may not be used
 - GPL 1,2,3; AGPL 3; LGPL 2,2.1,3
 - BSD 4-clause
 - Facebook BSD + Patents license
 - JSON license
 - ...

Requesting ToC vote on adopting the following "3rd party code use policy"

- Use 3rd party code allowed if:
 1. 3rd party code under a license from the list below
 - BSD-2-Clause
 - BSD-3-Clause
 - MIT
 - FSFAP (Free Software Foundation All Permissive)
 - GPL-2.0-or-later with Bison-exception * (Code must be generated by Bison)
 - Python 2
 - Google IP grant for Golang
 2. Code unmodified in designated 3rd –party directory, with original license and other claims.
- Other uses require case-by-case review and approval from ToC
